- 5. Are there activities we should be adding to further our mission for the upcoming year?
- 6. For budget items not directly related to activities:
 - Is this expense necessary for the operations of CCW?
 - Does this expense further our mission?
- 7. For those activities we want to continue or add and those necessary expenses please determine an income or expense amount to include in the upcoming budget.
- 8. Are there any extraordinary items or capital expenses we may want to consider in the upcoming budget?
